- Measurable change in the quality management outcomes of your practice or workplace
- Measurable improvement in patient safety outcomes in your practice or workplace
- Measurable improvement in patient and/or provider engagement outcomes in your practice or workplace

- The opportunity to briefly present a project summary at the 48<sup>th</sup> Annual Conference to demonstrate your achievement
- A crystal CHCQM Diplomate Achievement Award with an LED base
- Complimentary registration to the ABQAURP's 2025 Annual Conference to be held September 11-12, 2025, in Clearwater Beach, Florida
- Complimentary 2-night stay (September 10-11, 2025) at the beautiful Sheraton Sand Key Resort

### **Eligibility:**

- The improvement in health care quality management and/or patient safety must have occurred between 2020 and 2024 and started no earlier than 2020.
- Applicants must be ABQAURP Diplomate members in good standing and be able to attend the 2025 Annual Conference.



## Scoring:

- The CHQM Award Selection Panel will be comprised of three (3) ABQAURP Diplomate Board Members, all of whom are Fellows of ABQAURP and experts in HCQM.
- The panel will independently review and score each submission using the selection criteria.

## Submission requirements:

- The submission, including relevant documentation, should be combined into a PDF **or** Word document (not to exceed 10 MB) and submitted electronically by email to [mmiller@abqaurp.org](mailto:mmiller@abqaurp.org).
- Using the submission form, please provide your contact information, project title, and a summary of your achievement in 1,000 words or less.
- Include a narrative of no more than three (3) additional pages, single-spaced, size 11 font or larger, to demonstrate the impact on health care quality and/or patient safety.
- Include any additional supporting documentation, such as endorsements or news clippings/articles, to be provided inside five (5) pages.
- Include a copy of your current Curriculum Vitae or resume.
- Include a high-resolution photo, minimum 300 dpi, .JPG image.
- Through your submission, you attest that all content submitted is original and belongs to you.
- All submissions must be received by 5:00 pm Eastern Time, January 15, 2025. The award winner will be notified by May 15, 2025.
